Second Trump Administration Overview

With Republican control of the White House, the Senate, and likely control of the House of Representatives, President-elect Donald J. Trump is expected to support policies that reduce illegal immigration, increase carbon-based energy production, dramatically raise tariffs, lower taxes, limit environmental regulations, support law enforcement, centralize executive power, expand U.S. missile defenses, and reduce U.S. foreign and military assistance to allies and partners. Over the next several months until 60 days after Inauguration Day on January 20th, 2025, the Government Services Administration (GSA) will provide office space and support services to President Trump and Vice President Vance. Trump is currently using his Mar-a-Lago property in Florida as a presidential transition headquarters.

Trump, dissatisfied with perceived institutional backstops to his 2017-2021 agenda, may operate outside of traditional institutional structures to pursue his policy agenda. This strategy aims to defang the perceived "deep state" staffing of numerous federal agencies. His efforts are expected to include repealing part of the Impoundment Control Act of 1974, allowing him to refuse to spend money appropriated by Congress for specialized programs. He is also expected to attempt to bring independent regulatory agencies, including the FTC and FCC, under presidential authority, and reinstate his executive order stripping federal employee protections.

Trump plans to reinstate Schedule F, an executive order that streamlines the firing of career civil servants, which, combined with extensive preparatory activity by Trump allies, may allow a second term Trump greater latitude to reinforce carefully selected political appointees with ideologically aligned agency staff.¹⁷ Much of Trump's agenda will require significant Congressional support to be effective.

The Republican-controlled Senate is expected to utilize the Congressional Review Act (CRA) to pull back targeted Biden executive agency rules that fall within the CRA's 60-day window. Even with Republican control of both chambers, the lack of a 60-vote majority in the Senate could mean that the filibuster remains a significant barrier to legislation. In response to Senate Democratic filibusters, Trump is likely to re-embrace executive orders to enact his favored policies. From 2017 to 2021, Trump issued more executive orders, 220 total, than any president had during a four-year term since President Jimmy Carter. 19

Projected policy stances of selected Trump Cabinet positions:

• Secretary of State:

- o Expected to counter China's territorial and economic ambitions in the Indo-Pacific.²⁰
- o Expected to pressure NATO members to spend more on defense.²¹
- o Expected to work with Israel and Arab countries to expand the Abraham Accords.²²

• Secretary of Defense:

- o Expected to reform the Pentagon's bureaucracy.²³
- o Expected to eliminate progressive Department of Defense policies.²⁴
- o Expected to oversee an expanded U.S. nuclear arsenal and missile defense infrastructure.²⁵

• Secretary of the Treasury:

- Expected to encourage financial de-regulation and free-market policies.²⁶
- o Expected to support a 20% corporate tax rate.27
- Expected to increase economic sanctions on Iran, Cuba, and Venezuela.²⁸

Attorney General:

- o Expected to investigate social-media censorship.²⁹
- o Expected to implement the mass deportation of undocumented immigrants.30
- Expected to mobilize the Department of Justice (DOJ) Antitrust Division to scrutinize big tech and other sectories accused of being monopolistic.³¹

Secretary of Homeland Security:

- Expected to implement a zero-tolerance illegal immigration policy.³²
- o Expected to oversee the mass-deportation of undocumented immigrants.³³
- o Expected to limit student and spousal work authorization.³⁴
- o Expected to limit refugee admission levels.35
- o Expected to end the Humanitarian Parole Program for nationals of Cuba, Haiti, Nicaragua, and Venezuela.³⁶
- o Expected to end Temporary Protected Status.³⁷

• Secretary of Commerce:

- Expected to enforce high tariffs on imported goods, with a particular focus on goods from China.³⁸
- o Expected to prohibit critical technology exports to rival countries.³⁹
- o Expected to investigate U.S. corporations suspected of violating tariff policies.⁴⁰

• Secretary of Energy:

- o Expected to maintain U.S. energy independence.41
- Expected to expand carbon-based energy production.⁴²
- Expected to reduce regulations on energy companies.⁴³

• United States Trade Representative (USTR):

- Expected to oversee the expansion of import tariffs to secure trade concessions.⁴⁴
- o Expected to shift U.S. focus from multilateral to bilateral trade agreements. 45
- o Expected to strengthen the enforcement of U.S. trade laws related to IP theft and foreign subsidies.⁴⁶

• Environmental Protection Agency (EPA) Administrator:

- Expected to reconsider the EPA's 2009 conclusion that greenhouse gases endanger public health to roll back environmental protections.⁴⁷
- o Expected to eliminate EPA staff perceived as disloyal to the administration.⁴⁸
- o Expected to refrain from developing new environmental regulations.⁴⁹

Presidential Transition Overview

The U.S. federal government is one of the largest institutions on Earth, and transferring control of the government from an outgoing president to an incoming president is an incredibly complex process.⁵⁰ An incoming president-elect must begin making over 4,000 political appointments, including over 1,200 positions requiring Senate confirmation.⁵¹ Since 1963, the Government Services Administration (GSA) has been authorized funding to assist the president-elect with the transition. Since 2010, the GSA has been required by law to help eligible party candidates with administrative preparation following the major party conventions.⁵² However, these GSA services require a presidential candidate transition team to coordinate with to have an impact.

During the 2024 presidential election, both the Trump and Harris campaigns were historically late in selecting the leaders of their respective transition teams.⁵³ Recent history indicates significant uncertainty when the departing incumbent president and the incoming president-elect are from different political parties. In 2020, Trump administration GSA Administrator Emily Murphy waited 16 days before offering the incoming Biden administration the administrative support required by the 1963 Transition Law.⁵⁴ As a result of this delay, a bipartisan reform to the Electoral Count Act was signed into law in 2022, which clarifies the GSA administrator's role following a presidential election.⁵⁵

On the day after the election, the GSA must provide office space and support services to the president-elect and vice president-elect, with support continuing up to 60 days after the inauguration. Additionally, the president-elect receives a classified national security summary as soon as possible after the election.⁵⁶

Trump Transition Team

In August, Trump named Howard Lutnick and former Small Business Administration Administrator Linda McMahon as co-chairs,⁵⁷ and Vice President-elect J.D. Vance (R-OH), Donald Trump Jr., and Eric Trump as honorary transition team co-chairs.⁵⁸ Additionally, former Rep. Tulsi Gabbard (D-HI) and Robert F. Kennedy Jr. are involved with the Trump transition team.⁵⁹ Also, Trump announced plans to place Elon Musk in charge of a government efficiency commission in a second Trump administration.⁶⁰

Presidential Transition Timeline

- **April 2024:** The Office of Management and Budget (OMB) published a Memorandum for Heads of Executive Departments and Agencies.⁶¹
 - This memorandum provides guidance to all executive departments and agencies on assisting the presidential transition activities required by the Presidential Transition Act of 1963.
- October 1, 2024: The GSA negotiated memorandums of understanding with transition teams, including agreement by transition teams to implement and make public their ethics plans.⁶²
- November 1, 2024: The Agency Transition Directors Council ensured that transition briefing materials are prepared. 63
- November 5, 2024: Election Day
- **Post-election (once there is clarity on the outcome):** On the day following a concession of all but one eligible candidate, or the determination of a sole apparent successful candidate, GSA continues to provide office space and support services to the president-elect and the Vice president-elect, with support continuing up to 60 days after inauguration.⁶⁴
- <u>Post-election (once there is clarity on the outcome)</u>: A classified summary regarding national security is given to the president-elect as soon as possible after the election.⁶⁵
- <u>Post-election (once there is clarity on the outcome)</u>: Training and orientation activities commence for prospective presidential appointees.⁶⁶

New Government Outlook

Trump WH, GOP Senate, GOP House (GOP Trifecta)

Overview

• With Republicans controlling both chambers of Congress, Trump will be (with the exception of the Senate filibuster) largely unconstrained in implementing his agenda, even with small majorities in the House and Senate. Trump and his loyalists might pressure Senate Republican institutionalists, like Sen. Mitch McConnell (R-KY), to scrap the filibuster to pass Trump priorities via a simple Senate majority.⁷³ Trump and a unified Republican Congress may seek to enact numerous Trump agenda items, including ending birthright citizenship for the children of undocumented immigrants,⁷⁴ deporting over one million undocumented immigrants each year,⁷⁵ using DoD funds to build holding facilities to detain undocumented immigrants,⁷⁶ repealing the Impoundment Control Act of 1974,⁷⁷ authorizing military force against Mexican drug cartels,⁷⁸ limiting U.S. foreign assistance,⁷⁹ and ending U.S. military aid to Ukraine,⁸⁰ among other priorities. It is unclear if the congressional Republican plans to focus on the *Loper Bright* SCOTUS decision, which undid the longstanding *Chevron* doctrine, will receive significant attention with Trump back in the White House.⁸¹ Republican lawmakers could be restrained in their efforts to weaken federal agencies if those agencies are staffed with Trump loyalists and led by Trump nominees.

Senate

• Senate Republicans will proceed with a coordinated attempt to extend the TCJA tax cuts and boost other Republican priorities, like expanding carbon-based energy production and increasing DoD funding, via budget reconciliation. 82 Budget reconciliation is a congressional procedure to expedite the passage of Senate legislation dealing with spending, revenue, and the debt limit, with a simple majority of 51 Senate votes (or 50 Senate votes with the vice president serving as tie-breaker) for passage. 83

However, new Trump tax cut proposals, including expanding the SALT cap and eliminating tip taxes, may face resistance from Republican fiscal hawks. Also, it is possible that Trump's pressure on Senate Republicans to nuke the filibuster will not emerge until after the budget reconciliation process. Additionally, Senate Republicans are unlikely to reject Trump's nominees for cabinet positions. However, moderate senators and institutionalists may scrutinize nominees for critical roles, such as the Attorney General, Secretary of Defense, Secretary of State, and Secretary of the Treasury. Sen. John Thune (R-SD) will replace Sen. Mitch McConnell (R-KY) as Senate majority leader, which increases the likelihood of a degree of institutional Senate Republican continuity at the leadership level.

- Senate Republicans may use their majority to empower the *Chevron*-decision working group, led by Sens. Eric Schmitt (R-OK), Kevin Cramer (R-ND), Cynthia Lummis (R-WY), Rick Scott (R-FL), John Cornyn (R-TX), and John Thune (R-SD). 88 This group intends to limit the administrative state's exercise of power following the Supreme Court's (SCOTUS) Chevron decision in 2024. The now defunct Chevron doctrine required federal courts to defer to federal agencies' reasonable interpretations of ambiguous laws, and the Supreme Court's ruling means that courts must now interpret federal statutes without being required to accept an agency's interpretation of an ambiguous statute. 89 This effort is expected to initially target 101 federal agencies that have published over 50 final rules since 2000. 90
- With control of the White House and both congressional chambers, Republicans will likely use the Congressional Review Act (CRA) to strip federal agency regulations enacted under the Biden administration. CRA will mainly be used to target environmental rules. 91 Partisan committee hearings into past Biden administration policies will continue with Republican control of the House as a tool to project the effectiveness of Trump's actions and policies. Additionally, should House Republicans succeed in pushing a national abortion ban 92 through both chambers, Trump may veto the bill. 93

The following members of the Senate are likely to be contenders for committee chairs, and the following policy priorities are likely to receive focus:

• Senate Agriculture

- A GOP-led Senate Agriculture Committee will focus on supporting a 2025 Farm Bill (2018 Farm Bill has been extended twice)
 that uses IRA funds to support USDA conservation programs, limiting the president's ability to increase SNAP payments, and supporting private crop insurance companies, increasing logging in private and public forests to reduce wildfires.⁹⁴
- o Current Ranking Member Sen. John Boozman (R-AR) is expected to chair the committee. 95

Senate Armed Services

Senate Banking

- A GOP-led Senate Banking Committee will be focused on opposing the SEC's climate disclosure rule, limiting the power of the CFPB, supporting Treasury Department sanctions on foreign adversaries like Iran, increasing the housing supply, expanding investigation into Chinese shell companies, and streamlining access to funding through capital markets.⁹⁸

• Senate Commerce, Science, and Transportation

- A GOP-led Senate Commerce Committee will be focused on actively overseeing big tech firms perceived to be anticonservative, supporting regulation of disinformation technology like deepfakes, supporting oversight of Boeing, opposing Biden administration electric vehicle (EV) subsidies, and supporting carbon-based energy company mergers.
- o Current Ranking Member Sen. Ted Cruz (R-TX)¹⁰¹ is expected to chair the committee. ¹⁰²

Senate Energy and Natural Resources

- A GOP-led Senate Energy and Natural Resources Committee will be focused on supporting efforts to oversee and limit the Bureau of Land Management (BLM), supporting Federal Energy Regulatory Commission (FERC) reform, opposing Department of Energy efforts to support EV-use, and supporting nuclear power expansion.
- Sen. Mike Lee (R-UT) is expected to chair the committee. 104

• Senate Environment and Public Works

- A GOP-led Senate Environment and Public Works Committee will be focused on supporting gas, coal, and nuclear power plants, oversight and criticism of IRA implementation, actively seeking to expedite the federal permitting process, and opposing the Federal Highway Administration's emissions mandate.¹⁰⁵
- Current Ranking Member Sen. Shelley Moore Capito (R-WV) is expected to chair the committee. 106

• Senate Finance

A GOP-led Senate Finance Committee will be primarily focused on extending the TCJA,¹⁰⁷ as well as opposing the OECD PillarOne global taxing rights initiative, supporting lower corporate taxes, decreasing prescription drug shortages, attempting to regulate and eliminate the fentanyl supply chain, rhetorical support for limited free trade, and oversight of social security disability insurance rules.¹⁰⁸

Sen. Mike Crapo (R-ID), current committee ranking member, will chair the committee.

House of Representatives

• House Republicans are likely to be more proactive in advancing Trump's agenda than the Senate, and the lower chamber will attempt to pressure their upper chamber Republican colleagues to tack to the right on policy changes as they undergo budget reconciliation. House Republicans appear eager to include non-TCJA related provisions during budget reconciliation, including restoring the "Remain in Mexico" policy, decreasing mandatory federal spending, opening the Alaska National Wildlife Refuge for carbon-based energy exploration, and other energy funding initiatives alongside tax cut extensions. House must elect a new Speaker at the onset of the 119th Congress in January 2024. It is likely that Rep. Mike Johnson (R-LA) will be elected Speaker of the House by Republicans due to his strong relationship with Donald Trump. However, there is some uncertainty as to whether the most conservative members of of the conference will be less disruptive than they were over the past two years. The result of the divisions within the House Republican Conference led to the ouster of former-Speaker Kevin McCarthy (R-CA). It is possible that Democrats could leverage potential House Republican divides to disrupt the selection of a Speaker. Additionally, President Trump's nomination of Rep. - A GOP-led House Education and Workforce Committee will be focused on supporting efforts to limit OSHA's authority, attempting to limit pro-trans related interpretations of Title IX, opposing perceived abuses of large labor unions, investigating antisemitism at universities, robust oversight of the Employee Benefits Security Administration, and opposing activities of the National Labor Relations Board (NLRB).¹²⁵
- Either Rep. Tim Walberg (R-MI), Rep. Joe Wilson (R-SC), or Rep. Burgess Owens (R-UT) is expected to chair the committee.

• House Energy and Commerce:

o A GOP-led House Energy and Commerce Committee will be focused on opposing Biden administration electric vehicle (EV) subsidies, supporting carbon-based energy company mergers, supporting Federal Energy Regulatory Commission (FERC) reform, opposing Department of Energy efforts to support EV-use, and supporting nuclear power expansion.¹²⁷

• House Financial Services:

o A GOP-led House Financial Services Committee will be focused on supporting the activities of the Bipartisan AI Working Group, opposing perceived progressive influence at the Federal Reserve, opposing the SEC's equity market structure reforms, attempting to narrow the scope of White House restrictions on outbound investment to China, robust oversight and criticism of the CFPB, and opposing a central bank digital currency (CBDC).¹²⁸



- Supports imposing a temporary 10% cap on credit-card interest rates.²²²

The highest legislative priority of the new Trump Administration and the Republican Congress will be to extend the 2017 Tax Cuts and Jobs Act and enact several additional proposals made by President-elect Trump during the campaign. The tax package may include the following:

- o Extending limits on individual Alternative Minimum Tax
- Extending doubling of the standard deduction
- o Keeping Child Tax Credit at \$2,000
- o Allowing the state and local tax deduction cap to expire
- o Eliminating taxes on Social Security benefits
- Eliminating taxes on overtime pay
- Eliminating taxes on tips
- o Potentially exempting all military and first responders from federal income taxes
- o Reducing the corporate tax from 21 to 15 percent for domestic manufacturers
- o Extending the research and experimentation deduction and other TCJA business provisions
- o Repeal of certain Inflation Reduction Act tax credits

- Pledges to repeal the Biden administration's 2023 AI Executive Order²²⁴ and replace it with a policy supporting "AI Development rooted in Free Speech and Human Flourishing."
- Likely supports limiting the regulation of AI technology.²²⁶
- Expected to ensure the United States remains a leader in AI technology through export controls.²²⁷
- Opposes the use of AI for censorship by American companies.²²⁸
- Supports refraining from selling U.S. government bitcoin holdings and establishing a strategic national bitcoin stockpile.
- Supports promoting the use of trustworthy AI in the federal government.²³⁰
- May support rolling back the FCC's net neutrality rules.²³¹

- Supports enacting a 10% to 20% across-the-board tariff on all imports.²³² ²³³
 - o Trump may favor declaring the U.S. trade deficit to be a national emergency, allowing the president to invoke the International Emergency Economic Powers Act and institute universal tariffs.²³⁴
- Trump has mentioned enacting a 60% or greater tariff on all Chinese goods.²³⁵
- Promises to enact 100% tariffs on nations that cease using the U.S. dollar for trade.²³⁶
- May support repealing China's permanent normal trade relations (most-favored nation) status. 237
- Favors phasing out all U.S. imports of essential goods from China over four years. 238
- Supports enacting 200% tariffs on cars made by Chinese-owned plants in Mexico.²³⁹
- Wants to pass a "Trump Reciprocal Trade Act," forcing U.S. trading partners to pay reciprocal identical tariffs to the United States for tariffs they impose on U.S. exports.²⁴⁰
- Vows to end U.S. participation in the Indo-Pacific Economic Framework for Prosperity (IPEF) by boycotting meetings. ²⁴¹
- Likely supports removing some sanctions on Russia in an attempt to induce a negotiated end to the Russo-Ukrainian War.²⁴²
- Increasing sanctions on Cuba.²⁴³

- May consider abandoning the U.S-Mexico-Canada (USMCA) trade agreement when it up for extension in 2026, in a response to the increasing U.S. trade deficit with Mexico.²⁴⁴
- Supports establishing a U.S. sovereign wealth fund paid for by new revenue derived from expanded tariffs on trade.²⁴⁵

Congressional Procedures

Budget Reconciliation

- Budget reconciliation is a Congressional procedure to expedite the passage of specific Senate filibuster legislation.²⁴⁶ Budget reconciliation overrides the Senate's 60-vote filibuster supermajority rule, allowing a simple majority of 51 votes (or 50 votes with the vice president serving as the tie-breaker) for passage.²⁴⁷ Budget reconciliation bills can deal with spending, revenue, and the federal debt limit.²⁴⁸ In order for budget reconciliation to occur, a budget resolution, which determines how much budget reconciliation can raise the deficit, must be drafted by the congressional authorizing committees.²⁴⁹ Policies unrelated to the budget are limited by the Byrd Rule, which bars budget reconciliation bills from increasing the federal deficit after 10 years or changing Social Security.²⁵⁰ Budget reconciliation was used to pass the Tax Cuts and Jobs Act (TCJA) in 2017²⁵¹ and the American Rescue Plan in 2021.²⁵²
- Speaker Mike Johnson (R-LA) and other GOP congressional leaders believe congressional Republicans fell short in 2017, using budget reconciliation exclusively on TCJA instead of expanding the scope of their efforts. ²⁵³ Johnson advocates a whole-of-government approach, tasking nine GOP House committee chairs to produce policy wish lists for a potential 2025 Budget Reconciliation package. ²⁵⁴ The package will include efforts to extend and expand the TCJA, and may also include border security and energy production initiatives. ²⁵⁵

- Republicans may stop short of using budget reconciliation to repeal the Inflation Reduction Act (IRA) entirely, and they are unlikely to attempt another Affordable Care Act (ACA) repeal.²⁵⁶ With a Republican congressional majority, the biggest threat to their budget reconciliation ambitions is intra-party division, which could significantly hinder their legislative goals.
- Senate Minority Leader Mitch McConnell (R-KY) is an important actor in building the groundwork for a budget reconciliation package that extends the TCJA and boosts DoD funding.²⁵⁷ Senate Republicans regret perceived foot-dragging in early 2017, which they claim hampered their budget reconciliation effort. As a result, they are hoping to move fast with a fully formed strategy for budget reconciliation in 2025.²⁵⁸ Among House Republicans, in April 2024, the House Ways and Means Committee established ten Committee Tax Teams to study key provisions from the TCJA and identify legislative solutions to extend them.²⁵⁹ Some Republicans want to use a Republican Senate majority to extend the TCJA individual provisions without changing the corporate tax rate. Other Congressional Republicans think the corporate tax rate is too low and are interested in raising it.²⁶⁰ Another concept gaining traction in the GOP is canceling the employee retention tax credit and using that money to offset business tax credits that were eliminated to pay for the TCJA.²⁶¹

Congressional Review Act

- The Congressional Review Act (CRA) is a tool Congress can use to overturn specific federal agency actions. The CRA requires federal agencies to report the issuance of rules to Congress and provides Congress with unique procedures to consider legislation to overturn rules. If a CRA joint resolution of disapproval is approved by both chambers of Congress and signed by the president, or if Congress successfully overrides a presidential veto, the rule at issue cannot go into effect or continue in effect. A CRA joint resolution of disapproval must be introduced during a 60-days-of-continuous-session period beginning on the day Congress receives the rule.
- The first half of 2024 saw a race among federal agencies to finalize regulations, driven by the need to limit the impact of CRA efforts in the event of a Donald Trump victory and Republican control of Congress in 2025. Biden administration officials set a deadline of late May 2024 to conclude critical regulations.
- In 2017, Trump and congressional Republicans used the CRA to cancel 16 Obama administration rules. A 2025 Congressional Republican majority may be able to cancel the Federal Reserve and FDIC's Basel II endgame capital requirement rules via CRA. Republicans may also attempt to reverse Biden administration labor policies being advanced by the FTC and other agencies. Another potential target: Biden administration environmental rules, including restrictions on mercury from coal power stations and restrictions on carbon emissions from new gas power stations.
